BACKGROUND INFORMATION:

The purpose of the ordinance is to (i) adjust those assessments in the cases where Council finds it appropriate, (ii) confirm all other assessments, and (iii) amends the District boundaries as Council finds appropriate. The ordinance will also order the recording of the assessment roll as amended in Horry County offices and the sending of a letter to each person who filed an objection.

AN ORDINANCE AMENDING AN ORDINANCE OF THE CITY OF NORTH MYRTLE BEACH, SOUTH CAROLINA ENTITLED "AN ORDINANCE OF THE CITY OF NORTH MYRTLE BEACH, SOUTH CAROLINA AUTHORIZING THE ESTABLISHMENT OF THE CHERRY GROVE IMPROVEMENT DISTRICT; PROVIDING FOR THE FINANCING OF IMPROVEMENTS CHERRY GROVE IMPROVEMENT ASSESSMENTS, ISSUANCE OF BONDS, OR OTHER REVENUES AS HEREIN DESCRIBED; APPROVING AN ASSESSMENT ROLL AND THE SENDING OF A NOTICE OF THE ASSESSMENT TO PROPERTY OWNERS; APPROVING CERTAIN PUBLICATIONS; AND OTHER MATTERS RELATING THERETO", AS PREVIOUSLY AMENDED, TO RECLASSIFY CERTAIN ASSESSMENTS IMPOSED WITHIN THE CHERRY GROVE IMPROVEMENT DISTRICT, TO EXCLUDE CERTAIN PARCELS FROM THE ASSESSMENT DISTRICT, TO CONFIRM ALL REMAINING ASSESSMENTS SO IMPOSED, TO AMEND AN IMPROVEMENT PLAN RELATED THERETO, TO PROVIDE FOR THE FILING OF THE ASSESSMENT ROLL AND NOTIFICATION OF PROPERTY OWNERS, AND OTHER MATTERS RELATED THERETO

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTH MYRTLE BEACH, SOUTH CAROLINA, AS FOLLOWS:

Section 1. Findings.

The City Council (the "City Council") of the City of North Myrtle Beach, South Carolina (the "City"), hereby finds and determines:

- (a) As set forth in a resolution adopted by the City Council on January 12, 2015 (the "Resolution"), the City has caused to be prepared an "improvement plan" (within the meaning of Section 5-37-20(4) of the Code of Laws of South Carolina, 1976, as amended (herein, the "Code"), being a portion of the Municipal Improvement Act of 1999, as amended (herein the "Act")), entitled "CHERRY GROVE IMPROVEMENT PLAN PREPARED FOR THE CHERRY GROVE IMPROVEMENT DISTRICT NORTH MYRTLE BEACH, SOUTH CAROLINA" (the "Improvement Plan"), which Improvement Plan contemplates the establishment of an "improvement district" (within the meaning of Section 5-37-20(3) of the Act) to be known as the Cherry Grove Improvement District (the "Improvement District"). The Improvement Plan contemplates the dredging of certain canals within the Improvement District as more particularly described therein (collectively, the "Improvements") which constitute "improvements" within the meaning of Section 5-37-20(2) of the Act.
- (b) The City Council on April 6, 2015, enacted an ordinance entitled "An Ordinance Of The City Of North Myrtle Beach, South Carolina Authorizing The Establishment Of The Cherry Grove Improvement District; Providing For The Financing Of Improvements Within The Cherry Grove Improvement District By Assessments, Issuance Of Bonds, Or Other Revenues As Herein Described; Approving An Assessment Roll And The Sending Of A Notice Of The Assessment To Property Owners; Approving Certain Publications; And Other Matters Relating Thereto" (the "Original Assessment Ordinance").
- (c) The Original Assessment Ordinance establishes the Improvement District and the imposition of assessments on property located within the Improvement District, as shown on an assessment roll (the "Assessment Roll") approved by the Original Assessment Ordinance.

- (d) The Original Assessment Ordinance was amended by an ordinance entitled "An Ordinance Amending An Ordinance Of The City Of North Myrtle Beach, South Carolina Entitled 'An Ordinance Of The City Of North Myrtle Beach, South Carolina Authorizing The Establishment Of The Cherry Grove Improvement District; Providing For The Financing Of Improvements Within The Cherry Grove Improvement District By Assessments, Issuance Of Bonds, Or Other Revenues As Herein Described; Approving An Assessment Roll And The Sending Of A Notice Of The Assessment To Property Owners; Approving Certain Publications; And Other Matters Relating Thereto' To Approve An Amended Assessment Roll, Approve Changes In Certain Reports, Provide For The Publication Of Certain Notices, And Other Matters Related Thereto", which amendatory ordinance was enacted by the City Council on May 18, 2015 (the "First Amendatory Ordinance", and with the Original Assessment Ordinance, the "Assessment Ordinance").
- (e) Following the adoption of the First Amendatory Ordinance, the City mailed notice of the assessment authorized by the Assessment Ordinance to the owners of property located within the District as shown on the Assessment Roll in accordance with Section 5-37-120 of the Act.
- (f) The Council convened hearings on written objections to assessments filed with the City in accordance with Section 5-37-130 of the Act Code on June 11, 2015, June 30, 2015, and July 1, 2015.
- (g) Having considered the written objections so filed and those presentations at the hearings so convened, the Council has determined to adjust assessments against certain properties in the District, confirm all other assessments, to provide for the filing of the Assessment Roll in the offices of the Clerk of Court of Horry County and the Register of Deeds of Horry County, and to provide for the mailing of notice to all persons who filed written objections to assessments with the City.
- (h) While considering objections filed with the City, the Council has determined that it is not in the best interest of the City to dredge a canal located along 63rd Ave North, popularly referred to as the "Z Canal." The Z Canal separates 63rd Ave North from land bounded by Hog Inlet on the north and the Atlantic Ocean to the south. Based on information provided by the City's engineers and owners of property located on the Z Canal, the Council is concerned that, owing to the lack of a bulkhead along the eastern edge of the Z Canal, there is a risk of accelerated silting and filling of the Z Canal. Accordingly, the Council has determined that the Improvement Plan will be amended to exclude the dredging of Z Canal. As a consequence, the Council has determined that certain parcels along the Z Canal will not receive the previously expected special benefit and therefore has concluded that these should be excluded from the District.

Section 2. Approval of Changes to Assessment Roll and Improvement Plan.

The Council hereby orders the following changes to the Amended Assessment Roll as shown on Exhibit A:

- (a) In accordance with information provided by City staff; the parcels shown on Exhibit A Part I shall be reclassified as "non-buildable" and therefore have zero Equivalent Units, as defined in the Rate and Method of Apportionment of Assessment, and the assessment applicable thereto shall be set at \$0.
- (b) In accordance with information provided by City staff, the two parcels shown on Exhibit A Part II, previously classified as double lots (Land Use Class 1-B) shall be reclassified as single lots (Land Use Sub-Class 1-A), shall be reclassified as "single family" (Land Use Sub-Class A-1), and the assessment applicable thereto adjusted to \$23,582.

- (c) The Council has determined that the three parcels shown on Exhibit A Part III should be deleted from the Improvement District and the Assessment Roll, as the Council has found that such parcels presently have adequate access to portions of waterways that have the desired amount of water depth and thus are not likely to receive a special benefit from the Improvements.
- (d) The Improvement Plan is hereby amended to delete therefrom dredging in Z Canal and areas along 63rd Ave North and Canal Street, except as necessary to provide access to canals to be dredged along the south side of Channel Street and finger canals connecting thereto. In accordance with this amendment, the Council has determined that eighteen parcels shown on Exhibit A Part IV will no longer receive a special benefit from the dredge and are therefore excluded from the Improvement District.

Consistent with the changes noted above, the revised Improvement District is shown in Exhibit B, attached hereto.

Section 3. Filing of Assessment Roll; Mailing of Notice.

- (a) The City Manager is hereby authorized and directed to cause the Assessment Roll, as amended hereby and attached hereto as Exhibit C, to be promptly filed in the offices of the Clerk of Court of Horry County and the Register of Deeds of Horry County.
- (b) The City Manager is hereby authorized and directed to cause notice of Council's action regarding those assessments to which objections were filed to be mailed as provided in Section 5-37-130 of the Act.

Section 4. Saving Provision; Severability.

Except as amended hereby, the Amended Assessment Ordinance shall continue of full force and effect. The provisions of this Ordinance are hereby declared to be separate and if any section, phrase or provision shall for any reason be declared by a court of competent jurisdiction to be invalid or unenforceable, such declaration shall not affect the validity of the remainder of the sections, phrases and provisions hereunder.
